

DEED CONVEYING PROPERTY FROM CHAUTAUQUA COUNTY BRD OF SUPERVISORS TO BOY SCOUTS
THIS INDENTURE,

Made the 28th day of June in the year one thousand nine hundred and thirty-two.

BETWEEN The Board of Supervisors of Chautauqua County, New York, by its Chairman, M. P. Whallon of Mayville, N. Y. and its Clerk, J. A. McGinnies of Ripley, N. Y., party of the first part, and Chautauqua Lake Area Council Incorporated Boy Scouts of America, a membership corporation, organized and existing under and by virtue of the Laws of the State of New York, and having its principal office in the City of Jamestown, County of Chautauqua, State of New York, party of the second part.

WITNESSETH That the said party of the first part, in consideration of Fourteen hundred forty-four and 15/100 (\$1444.15), to it in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, and by virtue of Tax Certificate No. 229, Sale of 1930 and Certificate No. 250, Sale of 1931 has bargained sold, remised and Quit-Claimed and By These Presents, does bargain, sell, remise and Quit-Claim unto the said party of the second part, and to its heirs and assigns forever,

ALL THAT TRACT, PIECE OR PARCEL OF LAND, situate in the Town of Chautauqua, County of Chautauqua and State of New York, bounded North by lands of Mather, et al; East and West by highway; South by lands of Cornell, containing 336 acres, and being the same premises on part of Lots 34 and 39, Township 3, Range 13 assessed on the 1929 Chautauqua town roll in the name of A. N. Broadhead; EXCEPTING therefrom, 4½ acres deeded to A. G. Cornell and recorded in Liber 581 of Deeds at page 468. Being the same premises as were conveyed to William A. Broadhead and Margaret A. Broadhead by deed dated November 7, 1927, recorded in the Chautauqua County Clerk's office December 1st, 1927 in Liber 420 of Deeds at Page 293.
